"NW WAVEMAKERS" Personal Information Collection Statement

This Personal Information Collection Statement (this "Statement") is made by New World Development Company Limited ("NWD"), organizer of the "NW Wavemakers". "We" in this Statement refers to NWD.

NWD is part of the New World Group ("Group") which also includes New World Property Management Company Limited, Housing Finance Limited, New World China Land Limited, New World Department Store China Limited, K11 Concepts Limited, New World Loyalty Programme Limited, New World Group Charity Foundation Limited, K11 Art Foundation Limited, Khora Limited, Humansa Limited and other companies (including any joint venture companies where any of the Group's companies has an interest) from time to time whose activities include real estate (sale, leasing and investment), mortgage services, retail, facilities management, infrastructure, shopping malls, department stores, jewellery and luxury products, hotels, food and beverages, convention and exhibition centres, sports and recreational facilities, education and charitable pursuits including sports, recreation, art and cultural programmes, relief of poverty, advancement of education, advancement of religion, health care and senior care, and other purposes that are beneficial to the community (together referred to as "Affiliates").

In order to enable us to process your enrolment to NW Wavemakers and to provide you with the related information of our services, you are required to provide all the requested personal particular in the New World Harbour Race 2019 Racing Group Application Form/ Harbour Race 2019 Leisure Group Application Form (as the case may be) (HKID No. & Passport No. excluded). If you do not provide the required personal data, then we may not be able to process your enrolment to NW Wavemakers and to provide you with the related information of our services.

Purposes for using personal data

The personal data to be collected in the New World Harbour Race 2019 Racing Group Application Form / Harbour Race 2019 Leisure Group Application Form (as the case may be), including but not limited to name, date of birth, gender, age, contact details, e-mail and correspondence addresses, will be used for the following purposes:

- Process your enrolment to NW Wavemakers and to provide you with the related information of our services;
- [Contact you in connection with your enquiry and/or enrolment as member of NW Wavemakers];
- [informing you on any important information, future events and activities];
- [providing you with priority and exclusive service on event participation];
- Research and development in relation to customer behaviour;
- Direct marketing and cross-marketing, subject to consent (see below);
- Data analytics, profiling, information management and database administration;
- Detection, investigation and/or prevention of activities that may violate our policies or may be illegal;
- Collection or recovery of any debt owed by you to us or our Affiliates.

Those with whom we share personal data

We may engage agents, contractors, suppliers and service providers in connection with the above purposes, e.g. IT providers, marketing agents, social media and research companies, and may transfer to or share your personal data with them for such purposes. We may also share your personal data with our Affiliates and social media platforms we or our Affiliates used for the above purposes. Where we are required by the law of any country or requested by any court, regulatory body or governmental body of any country, we may also disclose your personal data as required. In the event of any transfer of business, transfer of shares, amalgamation or purchase of our business or our Affiliates' businesses, your personal data may be transferred to the new entity as part of the transaction, provided that the new entity abides by this Statement and continues to exercise the same level of care, in respect of your personal data, as we would.

We may also transfer your personal data to other sponsors or sub-sponsors of the New World Harbour Race, for the purpose of their provision of certain privileges to you. For instance, we may transfer your name, contact details, email and correspondence address to FTLife Insurance Company Limited ("FTLife") for the purpose of their provision of free personal accident policy to you.

Your personal data may be stored in servers located outside Hong Kong and/or shared with Affiliates located outside Hong Kong. However, we will take all reasonable measures to ensure that your data is stored and processed securely, regardless of the country in which it is stored, and we ensure that our Affiliates do the same.

Direct marketing

Subject to your consent, we may use your personal data, including your name and contact details, to send you special offers, news, information and marketing in relation to our products, services, events and charitable initiatives.

Subject to your consent, we may also, whether for gain or not, use your personal data for, or provide your name and contact details to, our Affiliates and/or our Marketing Partners so that they may send you special offers, news, information and marketing in relation to their products, services, events and charitable initiatives.
